Year 6 Residential Trip to London 17-19 June 2026

Dear Families,

We are planning a fantastic opportunity for Year 6 pupils to visit London for 3 days next year. The residential will be taking place in June 2026 to celebrate the end of their time at Highfield. I am sure you will agree that this is an amazing opportunity for your child to visit the capital city.

The provisional cost of the all-inclusive trip is £385 which includes travel, accommodation, all entrance fees, meals and tickets to the many tourist attractions we will attend. **However, we would like to help families meet the cost and will therefore subsidise the trip so that you will only pay £290 per child.**

Previous trips have included:

- National History Museum
- London Eye
- West End Theatre Show
- Meals out at Italian *and* American restaurants
- Madame Tussauds
- Harry Potter Tour
- "Door to door" coach travel to and from each attraction

To reserve a place for your child a **non-returnable deposit of £60** and parental consent by return of the attached slip is required by **Tuesday 15th July**. This is a strict deadline because beyond this point we will be purchasing tickets and confirming which attractions to attend.

The remaining balance is divided into instalments to help spread the costs over the academic year. Please keep note of the following payment schedule.

If you have an outstanding balance on the SCOPAY App it must be cleared. Any payments made toward this residential will be reallocated to clear outstanding amounts before being assigned to this residential (so that families do not accrue more debt).

It is important that all parents understand that instalments must be kept up to date. Failure to make regular payments at the agreed times may result in your child's place being forfeited and any money already deposited being lost. If your financial circumstances change and you are struggling to meet an instalment payment deadline, it is your responsibility to discuss this with the school as soon as possible.
